管理層報告

Financial Results

For the year under review, the Group recorded a loss of HK\$34 million and of which HK\$27 million was unrealised losses on financial assets at fair value through profit or loss. In addition, based on the prudent accounting approach, the Group has made HK\$2.9 million impairment loss of amount due from an investee company. Turnover of the Group was down by 81% from HK\$419,969,608 to HK\$79,621,122. Net asset value decreased by 37.9% from HK\$141,763,884 to HK\$88,029,526. The decrease is mainly due to the reduction in market value of the Group's investment portfolio. As at 31st March, 2009, cash and bank balances were approximately HK\$5 million.

Business Review

The financial crisis shocked the world economy, causing severe economic downturn and recession, and Hong Kong was inevitably affected. Over 80% of the Group's investment portfolios are listed securities, therefore, the Group's performance was materially affected by the adverse movements in capital markets and the economy. The portfolio of listed equities was diversified among companies operating in different industries. However the portfolios performance was pulled down by a weak market overall. In particular, the Hang Seng Index was down around 41% from 22,849.20 (31st March, 2008) to 13,576.02 (31st March, 2009). Market value of the Group's listed securities portfolio decreased by 37% from HK\$116,756,644 to HK\$73,447,618, which was in line with the Hang Seng Index's performance. The Group has adopted a more prudent investment approach given the current volatile economic environment. The management maintains a healthy gearing position with HK\$3,942,081 interest bearing liabilities.

財務業績

本年回顧,本集團錄得虧損約34,000,000港 元,其中大約27,000,000港元是按公平值於損 益賬列賬之財務資產之未變現虧損淨額。除此 之外,管理層基於審慎的會計方法,本集團為 應收投資公司款項之減值虧損作出2,900,000 港元撥備。營業額下跌81%由419,969,608港 元至79,621,122港元。淨資產值下跌37.9%由 141,763,884港元至88,029,526港元。主要原因 是本集團之投資組合的市值下跌。於二零零九 年三月三十一日,本集團銀行結餘及現金共約 5,000,000港元。

業務回顧

金融危機衝擊了整個世界經濟,導致嚴重經濟 不景氣和衰退,而香港無可避免地受影響。本 集團擁有的投資組合內超過80%是上市證券, 因此,本集團的表現亦大大受到資本市場和經 濟不利波動影響。上市證券投資組合已分散在 不同的公司及行業,但投資組合的表現仍然 受整體軟弱市況所影響。特別是恆生指數下 跌大約41%由22,849.20點(於二零零八年三月 三十一日)到13,576.02點(於二零零九年三月 三十一日)。本集團上市證券之市值亦下跌了 37%由116,756,644港元至73,447,618港元, 這和恆生指數的表現相約。本集團已採取更加 審慎的投資方法去面對當前動盪的經濟環境。 管理層保持一個健康的債務境況,付息借貸為 3,942,081港元。

管理層報告

Prospects

In 2008, the global economy encountered significant challenges. Most of the major economic powers fell into recession, unemployment surged and credit dried up. Equity markets around the world fell dramatically and remain volatile, with swings of 7% in any one day not uncommon. The G20 industrial nations have agreed to combat the worldwide financial crisis and have launched stimulus packages aimed to strengthen their economies. China has announced a US\$586 billion stimulus package to encourage domestic consumption and prevent a deeper recession. Following announcements of stimulus packages and other financial policies planned to be implemented by major economies worldwide, the Hang Seng Index started to rebound. It was up 23.6% from a low of approximately 11,000 on 27th October, 2008 to around 13,600 on 31st March, 2009. The significant financial support coming from major governments will improve investor confidence and the financial markets will gradually recover. However, there remains a high level of uncertainly in the market, which may cause further volatility.

In the coming year, the Group will continue to implement a prudent investment approach. The management will closely monitor the portfolio's performance and when necessary, make any prompt response in line with changes in the economy.

FINANCIAL REVIEW

Liquidity and financial resources

As at 31st March, 2009, the Group had bank balances and cash of HK\$5,000,222 (2008: HK\$9,205,670). The Board believes that the Group has sufficient financial resources to satisfy its commitments and working capital requirements.

As at 31st March, 2009, part of the listed equity securities of the Group had been pledged to secure margin facilities and loans granted by a related company.

Gearing Ratio

As at 31st March, 2009, the amount of total borrowings was HK\$3,942,081 (2008: NIL). The gearing being equal to approximately 4.48% (2008: NIL) of the net assets of HK\$88,029,526 (2008: 141,763,884).

Dividend

The Board has resolved not to recommend a payment of final dividend.

Capital structure

There was no change to the Group's capital structure for the year ended 31st March, 2009.

前景

於二零零八年,全球經濟遇到重大挑戰。大多 數的主要經濟實力體系給衰退、失業湧現和信 用收縮所動搖。在世界各地的股票市場明顯處 於下跌和動盪中,在一天內下跌7%已是司空見 價。G20工業國家已同意對抗全球金融危機和 已提出了多項刺激經濟方案以利經濟復甦。中 國宣佈動用586,000,000,000美元刺激國內消費 和防止經濟衰退加深。隨著主要經濟體系公佈 各樣的刺激方案和其它的財政政策實施,恆生 指數開始反彈。由二零零八年十月二十七日大 約11,000點回升至二零零九年三月三十一日大 約13,600點,上升了23.6%。來自主要政府的重 大財政支持將加強投資者信心,而金融市場亦 逐漸回穩。然而,市場上仍有許多不明朗因素, 也許會導致進一步動盪。

在來年,集團將繼續實施審慎的投資方法。管 理層將會緊密地留意投資組合的表現,如有必 要,將根據市場上的變化作出即時的反應。

財務回顧 流動資金及財政資源

於二零零九年三月三十一日,本集團銀行 結餘及現金共5,000,222港元(二零零八年: 9,205,670港元)。董事會相信,本集團具足夠 財政資源履行承諾及應付營運資金要求。

於二零零九年三月三十一日,本集團之部份上 市股本證券已抵押予關聯公司以獲取孖展及借 貸。

債務率

於二零零九年三月三十一日,本集團之信貸 合共3,942,081港元(二零零八年:無),相對 資產淨值約88,029,526港元(二零零八年: 141,763,884港元)債務率約為4.48%(二零零八 年:無)。

股息 董事會議決不建議派付末期股息。

資本結構

於二零零九年三月三十一日,本集團之股份結 構並沒有變動。

Capital commitment and contingent liabilities

As at 31st March, 2009, the Group had no material capital commitment and contingent liabilities.

Foreign currency fluctuation

The Board believes that the foreign exchange risk is minimal as the Group mainly uses Hong Kong dollars to carry out its business transactions.

Employment and remuneration policies

As at 31st March, 2009, the Group employed a total of 5 full-time employees (2008: 5), including the executive directors of the Group. Employees' remuneration are fixed and determined with reference to the market rate.

Share options

The Company does not have share option scheme.

Corporate governance

The Company has complied with the Code on Corporate Governance Practices as set out in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange ("Code") throughout the year ended 31st March, 2009, with deviations from code provisions A.4.1 of the Code only in respect of the service term of directors.

None of the independent non-executive directors of the Company were appointed for a specific term. But all the directors of the Company are subject to retirement by rotation according to the provisions under article 157 of the Articles of Association of the Company. As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the Code.

Mr. Li Kwok Cheung, George ("Mr. Li"), aged 48, is an executive director and the company secretary of the Company. Mr. Li has joined Upbest Group Limited since 1996. He is responsible for business development and marketing of the Group. He has been a dealing director of Upbest Securities Company Limited since 1st May, 2000. He holds a master's degree in international marketing from the University of Strathclyde in Glasgow, Scotland, United Kingdom and is a fellow member of the Association of Chartered Certified Accountants and an associate member of the Hong Kong Institute of Certified Public Accountants. He had worked as a senior manager of the compliance division (currently known as regulation division) of the Stock Exchange for seven years before joining the investment advisory and securities industry in 1995. Mr. Li had also served with an international audit firm for five years. Mr. Li is an investment adviser and a dealer registered under the Securities Ordinance and is a deemed responsible officer under the Securities and Futures Ordinance. Mr. Li is also an executive director of Upbest Group Limited (Stock code: 335). Saved as disclosed above, Mr. Li does not hold directorship in any listed public companies in Hong Kong during the past three years.

Mr. Cheng Wai Lun, Andrew, aged 36, is an executive Director of the Company. He holds a bachelor's degree in California State University, the USA. He has over eight years' experience in securities, corporate finance and direct investment. He is also an executive director of Upbest Group Limited (Stock Code: 335). Saved as disclosed above, Mr. Cheng does not hold directorship in any listed public companies in Hong Kong during the past three years.

Professionally, he is a fellow member of The Institute of Chartered Secretaries and Administrators in UK, The Hong Kong Institute of Company Secretaries and The Hong Kong Institute of Directors. He is also an associate member of the Hong Kong Institute of Certified Public Accountants, CPA Australia, Institute of Certified Management Accountants of Australia, and The Hong Kong Institute of Bankers. The financial results of the Group for the period from 8th June, 1999 (date of incorporation of Super Idea International Limited, a then wholly-owned subsidiary of the Company after the group reorganisation) to 31st March, 2000 were prepared on the basis of merger accounting as if the Group structure had been in existence throughout the period presented.

In accordance with the Company's Articles of Association, dividends can be distributed out of the share premium, contributed surplus and retained profits of the Company which in aggregate amounted to approximately HK\$77,529,000 (2008: HK\$93,898,000) as at 31st March, 2009.

The Audit Committee had also reviewed the annual results of the Group for the year ended 31st March, 2009 in conjunction with the Company's external auditors.

The audit committee of the Group consists of 3 independent nonexecutive directors, namely Mr. Chan Chung Yee, Alan, Dr. Fung Lewis Hung and Mr. Tang Hon Bui, Ronald.

Corporate Governance

The Company has complied throughout the year ended 31st March, 2009 with the Code on Corporate Governance Practices set out in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange, except that independent non-executive directors of the Company were not appointed for a specific term but are subject to retirement by rotation according to the Articles of Association of the Company. The Company adopted all the code provisions in the Code as its own code on corporate governance practices.

Corporate Governance Practice

With the assistance of the Compliance Department, the Board has designed a proper corporate governance structure. Currently, there are three board committees, including Audit Committee, Executive Committee and Remuneration Committee. Executive Committee assist the Group to set up business strategy and planning.

Board of Directors

Composition

The Company has adopted the Model Code set out in Appendix 10 of the Listing Rules as the code of conduct regarding securities transaction by the directors (the "Model Code"). Having made specific enquiry of all directors, the Company confirmed that all directors have complied with the required standards as set out in the Model Code during the year.

There is no relationship (including financial, business, family or other material relationship) among members of the Board.

Pursuant to the Articles of Association of the Company, the directors shall hold office subject to retirement by rotation at the annual general meeting of the Company at least once every three years and eligible for re-election.

Pursuant to Code provision A.4.1, non-executive directors should be appointed for a specific term, subject to re-election. None of the nonexecutive directors has entered or proposed to enter into any service contracts with the Company or its subsidiaries. Accordingly, the nonexecutive directors have no set term of office but they are subject to retirement by rotation at least once every three years. As such, the Board considers that sufficient measures have been taken to serve the purpose of the Code provision A.4.1.

Function

The Board of Directors, headed by the Chairman, is responsible for formulation and approval of the Group's development and business strategies and policies, approval of annual budgets and business plans, recommendation of dividend, and supervision of management in accordance with the rules governing the meeting of the Board of Directors, the Managing Director's working guides, articles of association and rules governing the meeting of shareholders.

The executive directors are responsible for day-to-day management of the Company's operations. These executive directors conduct regular meetings with the senior management of the Company and its subsidiaries and associated companies, at which operational issues and financial performance are evaluated.

The Company views well-developed and timely reporting systems and internal controls are essential, and the Board of Directors plays a key role in the implementation and monitoring of internal financial controls. 每名獨立非執行董事均已根據上市規則第3.13 條確認其獨立於本公司,而本公司亦認為彼等 確屬獨立人士。

本公司認為發展成熟及適時之申報制度及內部 監控為基本所需,而董事會在實行及監控內部 財務監控方面扮演重要角色。 The Board of Directors has established procedure to enable directors, upon reasonable request, to seek independent professional advice in appropriate circumstances, at the Company's expenses.

The articles of association of the Company contain description of responsibilities and operation procedures of the Board of Directors. The Board of Directors holds regular meeting and listens to the operating reports of the Company and makes policies. Significant operating policies of the Company have to be discussed and passed by the Board of Directors. Board meetings include regular meetings and irregular meetings. The Board of Directors meets formally at least 4 times a year.

Besides regular and irregular meetings, the Board of Directors obtains adequate information through working meetings, presided by the Chairman in a timely manner, to monitor objectives and strategies of the management, financial conditions and operating results of the Company and provisions of significant agreements.

For the financial year ended 31st March 2009, the Board of Directors held 5 regular Board meetings at approximately quarterly interval and 15 irregular Board meeting(s) which was/were convened when deemed necessary. Due notice and Board papers were given to all directors prior to the meeting in accordance with the Company's articles of association and the Code. Chairman and Managing Director

The roles of the Chairman and the Managing Director are segregated and assumed by two separate individuals who have no relationship with each other to strike a balance of power and authority so that the job responsibilities are not concentrated on any one individual.

The Chairman of the Board is responsible for the leadership and effective running of the Board. The Chairman is also responsible for deciding the agenda of each Board meeting, taking into account, where appropriate, matters proposed by other directors for inclusion in the agenda.

The Managing Director is delegated with the authorities to manage the Group's business in all aspects effectively, implement major strategies, make day-to-day decision and coordinate overall business operation.

The number of independent non-executive directors is nearly half of the Board membership. The Board membership is covered by professionally qualified and widely experienced personnel so as to bring in valuable contribution and different professional advices and consultancy for the development of the Company.

Responsibilities

In the course of discharging their duties, the directors act in good faith, with due diligence and care, and in the best interests of the Company and its shareholders. Their responsibilities include:

- Regular board meetings focusing on business strategy, operational issues and financial performance.
- Active participation on the boards of subsidiaries.
- Approval of annual budgets for each operating company covering strategy, financial and business performance, key risks and opportunities.
- Monitoring the quality, timeliness, relevance and reliability of internal and external reporting.
- Monitoring and managing potential conflicts of interest of management, Board members and shareholders, including misuse of corporate assets and abuse in related party transaction.
- Ensuring processes are in place to maintain the overall integrity of the Company, including financial statements, and relationship with other stakeholders, and compliance with all laws and ethics.

Internal Control and Risk Management

The Company places great importance on internal control and risk management. The Company is making comprehensive improvements to its internal control system and will implement a stricter and more regulated internal control system in the new financial year and disclose the relevant measures to the public in a timely manner.

The Board has established an on-going process for identifying, evaluating and managing the significant risks faced by the Group and this process includes updating the system of internal controls when there are changes to business environment or regulatory guidelines.

The Board is of the view that the system of internal controls in place for the year under review and up to the date of issuance of the annual report and financial statements is sound and is sufficient to safeguard the interests of shareholders and employees, and the Group's assets.

The investment manager assists the Board in the implementation of the board's policies and procedures on risk and control by identifying and assessing the risks faced, and involving in the design, operation and monitoring of suitable internal controls to mitigate and control these risks.

The key processes that have been established in reviewing the adequacy and integrity of the system of internal controls include the following:

- The Executive Committee is established by the Board to ensure the effectiveness of the daily operations and that the operations are in accordance with the corporate objectives and strategies.
- The Audit Committee of the Company reviews internal control issues identified by external auditors, regulatory authorities and management, and evaluates the adequacy and effectiveness of the Group's risk management and internal control systems.

Policies and procedures have been designed for safeguarding assets against unauthorised use or disposition; maintenance of proper accounting records for the use of reliable information within the business or external publication, and compliance of relevant regulations, rules and legislations. The policies and procedures are designed for providing reasonable but not absolute assurance to avoid fraud, material misstatements or errors.

Listing Rules Compliance

1. GENERAL

The Company is a public limited company incorporated in the Cayman Islands with its shares listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented.

a) Basis of preparation:

The financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. The financial statements have been prepared under the historical cost convention except that available-for-sale financial assets and financial assets at fair value through profit or loss are stated at fair value.

b) Basis of consolidation:

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated income statement from the effective date of acquisition or up to the effective date of disposal, as appropriate.

All significant intercompany transactions and balances within the Group have been eliminated on consolidation.

c) Property, plant and equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the assets to working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance and overhaul cost, is normally charged to the income statement in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of an item of property, plant and equipment, the expenditure is capitalised as an additional cost of the asset.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives using the straight-line method. The annual rate used for furniture, fixtures and equipment is 20%.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in the income statement in the year in which the item is derecognised.

Subsidiaries are all entities (including special purpose entities) over which the Group has the power to govern the financial and operating policies generally accompanying a shareholding of more than one half of the voting rights. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Group controls another entity.

Investments in subsidiaries are included in the Company's balance sheet at cost less any impairment losses. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

e) Investments:

The Group classifies its investments in the following categories: financial assets at fair value through profit or loss, loans and receivables and available-for-sale financial assets. The classification depends on the purpose for which the investments were acquired. Management determines the classification of its investments at initial recognition and re-evaluates this designation at every reporting date.

i) Financial assets at fair value through profit or loss

At each balance sheet date subsequent to initial recognition, financial assets at fair value through profit or loss are measured at fair value, with changes in fair value recognised directly in income statement in the period in which they arise. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the balance sheet date. h)

Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at each balance sheet date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset realised. Deferred tax is charged or credited to income statement, except when it relates to items charged or credited directly to equity, in which case the deferred tax is also dealt with in equity.

I) Related parties:

For the purposes of these financial statements, parties are considered to be related to the Group if the Group has the ability, directly or indirectly, to control the party or exercise significant influence over the party in making financial and operating decisions, or vice versa, or where the Group and the party are subject to common control or common significant influence. Related parties may be individuals (being members of key management personnel, significant shareholders and/or their close family members) or other entities and include entities which are under the significant influence of related parties of the Group where those parties are individuals.

m) Segment reporting:

A business segment is a Group of assets and operations engaged in providing products or services that are subject to risks and returns that are different from those of other business segments. A geographical segment is engaged in providing products or services within a particular economic environment that are subject to risks and returns that are different from those of segments operating in other economic environments.

n) Cash and cash equivalents:

For the purpose of the consolidated cash flow statement, cash and cash equivalents comprise cash on hand and demand deposits, and short-term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Pension obligations

The Group operates a defined contribution mandatory provident fund scheme (the "MPF Scheme") which is available to all employees. Contributions to the MPF Scheme by the Group and its employees are calculated at 5% of the employees' basic salaries with a maximum cap of HK\$1,000 per month. The Group's contributions to the fund are expensed as incurred and the assets of the MPF Scheme are held separately from those of the Group in an independently administrated fund.

Payments to the Group's MPF Scheme are charged as expenses as they fall due.

4. CRITICAL ACCOUNTING ESTIMATES AND JUDGMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The Group did not use any critical accounting estimates in the preparation of the financial statements.

In the process of applying the Group's accounting policies, management has made the following judgments, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Impairment of available-for-sale financial assets

For available-for-sale financial assets, a significant or prolonged decline in fair value below cost is considered to be objective evidence of impairment. Judgment is required when determining whether a decline in fair value has been significant and/or prolonged. In making this judgment, the historical data on market volatility as well as the price of the specific investment are taken into account. The Group also takes into account other factors, such as industry and sector performance and financial information regarding the issuer/investee.

5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of equity reserves attributable to equity holders of the Company, comprising issued share capital, other reserves and retained profits.

The directors of the Company review the capital structure on a semi-annual basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors, the Group will balance its overall capital structure through the payment of dividends and new share issues.

The Group's major financial instruments comprise available-for-sale financial assets, amounts due from investee companies, amounts due from related companies, other receivables, prepayments and deposits, financial assets at fair value through profit or loss, cash and bank balances, accruals and interestbearing borrowings.

The Group's activities expose it to a variety of financial risks: equity price risk, credit risk, liquidity risk, interest rate risk and foreign currency risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

i) Equity price risk

The Group is exposed to equity securities which are classified in the consolidated balance sheet either as available-for-sale financial assets or financial assets at fair value through profit or loss. These are susceptible to equity price risk arising from uncertainties about the future prices of the instruments. The Group's equity price risk is managed through diversification of the investment portfolio ratios by exposures.

The Group takes on exposure to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. Impairment provisions are provided for losses that have been incurred by the balance sheet date, if any. The Group is responsible for monitoring the amount of credit exposure to any financial institution.

iii) Liquidity risk

The Group invests in both listed and unlisted securities which are designated as availablefor-sale financial assets and/or financial assets at fair value through profit or loss. Those listed securities are considered readily realisable as they are listed in regulated stock exchanges. Those unlisted securities may not be traded in an organised public market and may be illiquid. As a result, the Group may not be able to liquidate quickly its investments in these instruments at an amount close to their fair value in order to meet its liquidity requirements or to respond to specific events such as deterioration in the creditworthiness of any particular issuer. Prudent liquidity risk management implies maintaining sufficient cash and marketable securities, the availability of funding through an adequate amount of credit facilities and the ability to close out market positions.

The Company and a subsidiary of Upbest Group Limited, Upbest Assets Management Limited ("UAML") as investment manager, have on 6th November, 2000, first entered into an investment management agreement pursuant to which UAML provided investment management services to the Company for a term of three years up to 30th November, 2003. Upon the expiration of the second investment management agreement for a period of three years commencing from 1st April, 2003, the same parties again on 31st March, 2006 entered into a supplemental investment agreement for the sole purpose of further extending the term of the second investment management agreement for another 3 years to 31st March, 2009.
